

Multiple Vat Return System

What is it?

If you're a Xero user and do business in multiple VAT jurisdictions you may have had problems creating your various VAT returns. You'll need to analyse all your sales and purchases and break them down into the different countries.

That's why we built the MultiVAT system!

How does it work?

All you need to do is set up a connection from MultiVAT to your Xero accounts and make sure that your transactions are broken down into different tax codes for different VAT jurisdictions.

When you select the start and end dates, MultiVAT will pull down all the relevant transactions from your Xero accounts and create report with the totals by tax code at the bottom. You can then put the various figures into the right VAT return. That's all there is to it!

Here's an example of what the report looks like.
